#### Elimination of Disparities in Coverage for Dental Procedures Provided under Medicare...

Resolved, that the Association seek legislation to provide fair and equitable treatment to all Medicare recipients by eliminating disparities in coverage for dental procedures, and be it further

Resolved, that the Association seek legislation which would provide for payment of dental services under Part B of Medicare in cases where the procedure is necessary and directly associated with a medical procedure or diagnosis.

Examples from 1993: kidney transplants, prosthetic heart valve replacement

#### **ADA Policies Related To Medicare**

#### Medically Necessary Care (Trans.1990:537)...

Resolved, that the following definition of "medically necessary care" be adopted:

Medically necessary care means the reasonable and appropriate diagnosis, treatment, and follow-up care (including supplies, appliances and devices) as determined and prescribed by qualified, appropriate health care providers in treating any condition, illness, disease, injury or birth developmental malformations. Care is medically necessary for the purpose of: controlling or eliminating infection, pain and disease; and restoring facial configuration or function necessary for speech, swallowing or chewing.

and be it further

Resolved, that the appropriate agencies of the Association distribute this definition of "medically necessary care" to third-party payers, plan purchasers, professional health organizations and state and federal regulatory agencies.



# What Do We Know About Dental Professionals' Views On Adding A Medicare Dental Benefit?




HPI survey - random sample of licensed, active US dentists in Jan 2018. From Families USA whitepaper July 2018

## Practice Patterns of US Dentists Are Changing:

Key Take Aways 1999-2017 HPI data

- Decline in solo practice
  overall
- 1 in 2 dentists in solo practice in 2017
- Only 1 in 5 dentists under 35 in solo practice
- Increasing proportion of women dentists in the workforce
- Women less likely to be in solo practice and be owners

### Build "It" And They Will Come...

**Perspective of Dental Professionals** 

- Experience with government programs has been mostly negative; i.e. State Medicaid programs
- Administrative and regulatory burden unknown; i.e. EHR and reporting requirements
- Most are in private practice and small business owners (high overhead with lab costs, etc. would not be covered by a facility fee)
- Reimbursement from commercial insurance products is declining and overall payer mix becoming more important

### **Perspective of Dental Professionals**

- Medicare program is not truly means tested not everyone needs it so prioritize those who most need it
- Older adults who really need the care may still have difficulty accessing it even with a dental benefit
- Most dentists are conservative and believe in a private sector "solution" versus expansion of an entitlement program

## National Academy of Medicine Dental Collaborative


"The purpose of this collaborative is to explore ways in which health literacy principles and practices can promote effective integration of dental health and general health into an actionable primary care model. Creation of this model will incorporate lessons learned from current models and will include perspectives from system players such as patients, providers, health care facilities, insurers and policy makers. The collaborative's ultimate goal is to catalyze action in the use of health literacy practices to promote integrated, coordinated, patient-centered care."

# In Conclusion

- Coalitions amplify the voice of oral health to policy makers and regulators
- Collaborative practice model (IPE) is taught in dental school and fits the millennial team orientation
- Increasingly more new dentists will seek opportunities to practice in collaborative groups

## **In Conclusion**

- Research supports the existence of a sufficient provider network
- ADA leadership needs to provide direction on how to implement their own policy
- Strengthen evidence-base by conducting prospective studies on relationship between chronic dx management and dental care
- Dentistry can (is poised to!) become an integral component of primary care through improved health outcomes, reduced cost, and better patient/provider satisfaction = Quad Aim
